

Both Matt Berryman and Quintin Primo offered remarks challenging everyone present to join together in giving generously for the sake of those we serve through Episcopal Charities.



An Introduction to Mr. Bryan Cressey, this year's honoree



"I decided to be a doer where I saw a huge need" Bryan C. Cressey began his career with First Chicago Equity Group and was one of the founders of the firm that became Golder, Thomas, Cressey, Rauner. He co-founded TCB in 1998 and Cressey & Company in 2008. His industry consolidation leadership has been recognized by Fortune and Time magazines, and his particular expertise in the healthcare services field has been widely acknowledged. A member of the Chicago Business Hall of Fame, and Chicago Area Entrepreneurship Hall of Fame, Bryan received his BS in Economics at the University of Washington and earned an MBA from Harvard Business School and a JD from Harvard Law School.

In addition to Bryan's professional identity, he has taken a serious and active interest in philanthropic work. Beyond supporting Episcopal Charities, Bryan also founded and personally funded Above and Beyond Family Recovery Center, a nonprofit alcohol treatment facility on the city's West Side.

Although alcoholism had touched his extended family, it was his volunteering with the homeless at Cathedral Shelter (now known as ReVive), also on the West Side, that propelled him to fund the treatment center. Mr. Cressey helped served food to those experiencing homelessness and, along with his three daughters, helped with tutoring. For years, he saw how alcoholism ravaged bodies and families.

"I decided to be a doer where I saw a huge need" he says of addiction and its "attendant scourges of homelessness, poverty and unhappiness." Today, in addition to Alcoholics Anonymous, The Above and Beyond treatment center offers Smart Recovery, a cognitive behavior therapy program. They also provide acupuncture, street yoga and programs that help patients find homes and jobs.


# A note from Cathedral Counseling Center

"The Cathedral Counseling Center is grateful to Episcopal Charities for the support which it has been able to offer the center during a year that has been complex and unpredictable. I had the privilege of becoming Board President of CCC in the fall of 2019, after the center had had an unexpected turnover of both senior staff and its Board. Although CCC is asset rich, the period of upheaval resulted in some pressing cash flow problems, and the ability of Episcopal Charities to offer the center a loan at a very critical point in its history (in addition to the regular grant funding that CCC has long enjoyed) has been a vital part of the center's journey into a sustainable future.

As a Ministry Partner of Episcopal Charities, and because of the critical support received in 2019 during a challenging season, we will continue providing seriously needed mental health counseling services to Episcopalians and others in the Chicagoland area."

# A Note from ReVive Center for Housing and Healing

ReVive has served those experiencing homelessness for over 100 years and is one of the original Ministry Partners of Episcopal Charities. All organizations go through changes and transitions that can be difficult and Revive has navigated a few of our own. In 1921, our home at the Cathedral of Saints Peter and Paul burned but we survived and moved boldly into the future. In recent months, we found ourselves asset rich but in need of a short-term bridge loan. Episcopal Charities stepped-in to provide a \$50,000 loan in addition to renewed grant support to insure Revive's future. Like in 1921, ReVive moves forward today recommitting to bringing hope and housing, seeking to take on the fast described by Isaiah as "loosing the bonds of injustice and bringing the homeless poor into our house". As the new interim CEO at Revive, I am grateful for the partnership with Episcopal Charities and look forward to the good work that lies ahead.
